#### Academic Profile

- Dr Qadri started his formal religious education at the age of 12 in Madinah Munawwara. He studied and completed his classical Islamic studies under the guidance of his father and the most eminent and famous scholars of Islamic classical sciences from a variety of places including Makkah Makarrama, Madinah Munawwara, Baghdad, Damascus, Beirut, Morocco and Mauritania.
- After completing his Masters in Islamic law and obtaining his LLB, he began his legal practice as an advocate from 1974 to 1978. Thereafter he joined the University of the Punjab as a lecturer of law where he completed his Ph.D in Islamic Law in 1986.
- Dr. Qadri was appointed as a Professor of Law and worked as the Head of the Department of Islamic Legislation and Constitutional Law (LLM), University of Punjab.
- Dr. Qadri was appointed as Jurist Consult for the Federal Shariah Court and later the Appellate Shariah Bench of the Supreme Court of Pakistan. He has also been an Advisor to the Federal Ministry of Education of Pakistan for the development of Islamic curriculum.

# Peace for Humanity Conference, London Shaykh ul Islam E

## Launch of Fatwa on Terrorism & Suicide Bombings














The United Nations Economic and Social Council (ECOSOC) has formally recognised and granted a 'Special Consultative Status' to Minhaj-ul-Quran International.

The launch ceremony, in February 2012, of Shaykh ul Islam Dr Muhammad Tahir-ul-Qadri's Fatwa on Terrorism and suicide bombings was attended by ministers, intellectuals, lawyers, journalists and renowned religious scholars.

#### Minhaj Welfare Foundation

Shaykh ul Islam Dr. Muhammad Tahir-ul-Qadri founded the Minhaj Welfare Foundation (MWF) to provide every possible help and assistance to the deprived and destitute classes of society. The main purpose of establishing this organization is to promote feelings of sympathy among people, create an environment conducive to foster mutual love, brotherhood and fraternity and strive for a real Islamic Welfare Society, taking all the sections of society along. To achieve this purpose MWF has embarked on projects in the fields of education, health and public welfare. It is through these fields of welfare work that the sacred task of serving humanity is being accomplished.

There are more than 1 billion people worldwide that are affected by extreme poverty. Out of which 780 million lack access to clean drinking water and more than 820 million people sleep hungry at night. It is estimated that every 3.6 seconds a person will die of starvation (the large majority of which are aged 5 or under)

MWF initiated the HelpFeed project in 2012. HelpFeed sets out simple solution to ending hunger and malnutrition by preventing short term difficulties and ensuring long term means of sustainability




